Mixing Directions: Thoroughly mix 1 part of Garlic Gard with 50-100 parts of water.

Application Directions:

Timing: For vegetables, spray several days before blooming. DO NOT apply just prior to or during pollination as Garlic Gard repels bees and, therefore, adversely affects pollination.

Method of Application: Garlic Gard may be applied by air or ground spray equipment.

Rate of Application: Set equipment to apply diluted spray to the point of runoff. Use of natural sticker/surfactant to increase foliar contact may enhance performance.

After Taste: Garlic Gard™ will leave no after taste on food crops.

Odor: Applied product becomes odorless to humans in minutes.

Storage: Store only in original container in a cool, dry place, inaccessible to children and pets.

Do not freeze.

Disposal: Rinse container thoroughly. Offer for recycling.

Sites: Terrestrial Food Crops.

Fruit Trees: Apple, apricot, peach, pear, plum and other tree fruit.

Nut Trees: Almond, pecan, walnut.

Citrus Trees: Lemon, orange, lime.

Vegetables: Beans, beets, cabbage, cucumbers, carrots, corn, herbs, lettuce, melons, onions, peas, peppers, potatoes, pumpkins, tomatoes.

Vine Crops: Berries, grapes, kiwi.

Ornamentals: (flowers, shrubs, and tree): For repelling aphids, bag worms, beetles, borers, chafers, curculios, cutworm, gypsy moth, leafhoppers, leafminers, maggots, mealy bugs, mites, plant bugs, saw flies, scales, spittle bugs, web

worms, and white flies.

Turfgrass: For repelling aphids, army worm, beetles, billbugs, chafers, chinch bugs, cut worms, ground pearls, Japanese beetles, leaf hoppers, lygus bugs, mites, mole crickets, spittle bugs, weevils, and web worms.

Animals, Birds and more: Garlic Gard™ repels elk, deer, field mice, fleas, gnats, iguanas, mosquitoes, rabbits and ticks.
